8. I agree to support and encourage my teammates, and to always try my best to try and keep a positive attitude.
9. I will respect the property and equipment used at any sports facility, both on and off the court.

6. I will treat all players, coaches, officials, parents, and spectators with dignity and in language, attitude, behavior, and mannerisms.
7. I will inform the coach of any physical disability or ailment that may affect the safety my athlete or the safety of others.
8. I will respect the property and equipment used at any sports facility, both on and off the court.
